Who else can contribute?

The proposals identified for Shaftesbury Square and the identified Development Opportunity sites in its vicinity will be taken forward with planned delivery over a period of 10 to 15 years. There is the potential for some proposals to be delivered almost immediately or in the short term resulting in "Quick Wins" bringing visible benefits to the area. Other larger more complex proposals will be delivered medium to longer term.

- Implement the Shaftesbury Square

- Facilitate and encourage the

Medium term (3-5 years)

- Implement public realm improvements along Sandy Row, Ormeau Road and
- **Donegall Pass.**
- Facilitate and encourage the development of a further 5 of the key
- opportunity sites.

Long term (5-15 years)

- Prepare for the implementation of the
- 2nd phase of Belfast Rapid Transit.
- Facilitate and encourage the development of a further 15 of the key
- opportunity sites.
- After 10 years, prepare a
- comprehensive review of the
- implementation of the Development Framework and adjust as appropriate.


