## Freedom of Information Act 2000

I wish to confirm that the Department has now completed its search for the information which you requested on 10 January 2024. My response to your queries is outlined below.

How many clubs in Northern Ireland were set to benefit from the Sub-Regional funding set aside for local football teams, which is yet to be released?

The Department is considering a range of options to deliver the long-standing Executive commitment to investment in modernising football facilities in Northern Ireland. The Department is still developing the programme and this information is not held. The Programme remains policy under development and this work is on-going.

Out of these clubs, would the Department be able to provide a percentage breakdown in terms of what clubs were getting what percentage of funding?

The information you have requested is not held. The Sub-Regional Stadia Programme remains policy under development and this work is on-going.

Does the Department believe that the funding amount (£36.2m) is enough and if not, what amount does it believe is now required to meet its commitments?

The budget allocated in 2011 is unlikely to be sufficient to deliver the expected outcomes for the programme. The Department has established options on the amount required to meet its commitment. I wish to advise you that the Department has decided not to disclose this information as it falls under the exemption in **Section 35(1)(a), the Formulation or Development of Government Policy**, of the Freedom of Information Act. In applying this exemption, we have had to balance the public interest in withholding the information against the public interest in disclosing the information.

The attached annex to this letter sets out the exemption in full, as well as the factors the Department considered when deciding where the public interest lay. It also includes a list of the types of documents analysed when considering your request.

Does the Department believe it is able to provide the additional money required on top of the original £36.2m if a Stormont Executive is restored?

It is for an Executive to consider and agree any changes in the funding available for this programme.

If you are dissatisfied with this response and wish to request a review of our decision or make a complaint about how your request has been handled, you may ask for an internal review within two calendar months of the date of this letter. - Any changes to the Sub-Regional budget would result in a change of direction for the Programme and its deliverables. Access to this information while the policy is still under development would hinder the ability of the Department to take forward any agreed policy as intended.
- The varied nature of stadia and facilities considered within the Sub-Regional Stadia Programme, along with inflationary pressures, make it difficult to be specific on the level of potential need. The information held is an estimate at a point in time.
   Disclosure of estimated information may close off discussion and the development of better options.
- A headline figure stating the amount required to meet the Sub-Regional Stadia Programme commitments may be misleading as there are other factors to be considered. The SRSPS is expected to be a competitive grant scheme, the final level of demand cannot be known until all applications have been assessed. Furthermore, not all applications are guaranteed to be

successful. The programme will be
subject to eligibility and assessment
criteria and those applicants who do
not meet these criteria may not be
developed).

The Sub-Regional Stadia Programme for Soccer remains policy under development. Information regarding costs are estimates at a point in time. There is a strong public interest in ensuring that the Department has safe space to work candidly and freely without being concerned that information could be released, which may be subject to change, and where it could be potentially misleading. The information held is dependent on the shape and scope of the Programme. Proposals are being prepared for an incoming Minister and may change. Any disclosure of this information could harm the decision-making process to a significant or substantial degree without any compensating benefit to the public.

In view of the above, the Department believes that the public interest in withholding this information outweighs the public interest in disclosing the information.
