

Redundancies are challenging for everyone involved.

Department for Communities (DfC) offers a free Redundancy Service offering support and useful information. The service is designed to give both employers and employees support and advice including:

- Helping people facing redundancy to create CVs
- Helping people to search for and find work
- Helping people identify their transferable skills and training needs
- Providing training to help people develop vocational skills
- · Providing general information about benefits
- Helping with costs like travel to work expenses
- Providing support to disabled people and people with health conditions and sign posting them to specialist disability employment organisations

The information contained in this factsheet will signpost you to up-to date information for employers.

What support is available for employers?

DfC offers a free Redundancy Service to help you and your employees through the process of redundancy. This service supports employers and employees as soon as people are 'at risk' of redundancy or during the period of notice. DfC can provide a tailored package of support through a network of partners, at no cost.
