INTRODUCTION

1 This Memo provides guidance on the Loans for Mortgage Interest (Amendment) Regulations (Northern Ireland)¹, which come into force on 15.3.21.

2 The regulations make minor changes in respect of Domestic Violence and Cold Weather Payments¹.

3 Support for mortgage interest loans are secured against the claimant's property through a legal or equitable charge against the property title and the loan is recoverable from any equity on the sale, transfer of ownership of the property or when the claimant dies. There is currently no exception to this provision^{1.}

Domestic Violence

4 Currently, a claimant fleeing domestic violence can be treated as occupying two properties for up to 12 months **only** where they have a liability to make owner occupier payments on both properties.

5 From 15.3.21 the claimant will be treated as occupying the family home, and qualify for a support for mortgage interest loan, if that is the only property the claimant is liable to make owner-occupier payments on^{1.} Housing costs may also be payable in respect of the property the claimant is living in temporarily².

Cold Weather Payments

6 In the circumstances where a person is awarded owner-occupier loan payments and is entitled to State Pension Credit it is confirmed that they do not have to meet the second condition of entitlement¹ and therefore they do not have to have a family member under 5 years of age.
